Audit Committee Members**

Statement of Issue:

Review proposed audit committee process to accommodate retirements and changes from the previous audit committee.

Background:

The Audit committee is comprised of three to five members, drawn from Board members with finance or accounting experience, and county staff with similar credentials. The committee independently receives a formal presentation of the audit report from the external auditors, and accepts the report for recommended approval to the Board.

Discussion:

In the past quarter, several committee members have taken on new roles and are no longer able to serve. Committee member Commissioner Bender, who served on this committee since 2019, has taken a new role and no longer serves as a Consortium Director. Committee member Helen Gornes (Hernando County) retired earlier than anticipated, and Committee member Yana Matiyuk (Pinellas) recently took a private sector job. This leaves one member of Audit committee, Richard Arthur, who is Charlotte County staff.

Since staff anticipates likely only needing one meeting with the external auditors, in lieu of standing up an entirely new committee this year, we propose a one-off meeting this year where we have a special Finance Committee meeting that includes the remaining Audit Committee member, Richard Arthur (Charlotte County). Mr. Arthur in combination with existing finance committee would serve as this year's audit committee. As a result, the 2024 Audit Committee would be composed as:

- Lawanda Pemberton (Taylor County)
- Patricia Wilken (Sarasota)
- Commissioner Robert Carroll (Bay County)
- Richard Arthur (Charlotte County)

Audit committee is designed to be independent of both staff and the Board, and report to the Board with its findings. To that end, one element of their duties is to meet with the auditors without staff present. This element would occur at this special meeting.
